U.S.-Mexico Trade: 2006 Figures Highest in Trade History

During the 2001-2003 period, U.S.-Mexico trade had been relatively flat. Since this period, trade between the partners continued to grow with each subsequent year-2003 (\$235.6 billion), 2004 (\$266.6 billion) and 2005 (\$290.2 billion).

Last year's 2005 figure was the highest ever recorded total trade dollar value (\$290.2 billion) between the trading partners. At the end of 2006, the total trade dollar value registered at \$332.5 billion-surpassing that of 2005 and making it the highest ever recorded.

In the first quarter 2006, estimates pointed towards continued increases in U.S. exports to Mexico and U.S. imports from Mexico. These increases were in the double-digit range for the 2006 year. Previously in 2005, the range of increase were below the double-digit range.

2006 exports dollar value finished with an 11.8 percent increase above last year's, and imports dollar value ended with a 16.5 percent increase over 2005. Therefore, total trade ended with a 14.6 percent increase (\$332.5 billion in total trade value) over 2005—\$290.2 billion (See Table 1). Along with the trade values, the U.S. trade deficit with Mexico also grew-\$64.1 billion in 2006 compared to \$50.2 billion in 2005.

The handling of merchandise (79.2 percent of the trade dollar value) in U.S.-Mexico trade is done primarily vía border ports of entry. Tables 2 through 6 delineate the activity at the border and the 27 ports of entry on the U.S.-Mexico border in terms of the dollar value of U.S. exports to Mexico, and U.S. imports from Mexico passing through them respectively.


Note from the Director

Indicators of border business activity for December 2006 end-of-year (EOY) demonstrated fourteen indicators increased and eight decreased. 2006 EOY comparisons to 2005 reported for the border are listed below:

- Pedestrian bridge crossings into Mexico were up 1.4 percent.
- Pedestrian bridge crossings into Texas were down 0.1 percent.
- Vehicle bridge crossings into Mexico fell 2.5 percent.
- Vehicle bridge crossings into Texas fell 4.6 percent.
- Truck bridge crossings into Mexico gained 6.5 percent.
- Truck bridge crossings into Texas gained 2.7 percent.
- Rail car bridge crossings into Mexico went up 1.7 percent.
- Rail car bridge crossings into Texas went up 18.4 percent.
- Revenues collected by U.S. Customs increased 1.8 percent.
- Revenues collected by U.S. bridge operators registered a gain of 8.3 percent.
- Tourist visas issued for entry into Mexico were up 3.5 percent.
- Total employment was up 3.4 percent, with 16,048 jobs gained. The average unemployment rate for the border in December 2006 was 5.1 percent.
- Total building permits issued rose 17.8 percent.
- Total building permit values increased 6.1 percent.
- Power connections in service for residential were up 2.6 percent, commercial were up 1.6 percent and industrial were down 0.6 percent.
- Air passenger arrivals were down 2.0 percent, and departures were down 2.1 percent.
- Total cargo for the Port of Brownsville increased 12.8 percent.
- Inbound cargo for the Port of Corpus Christi went down 0.9 percent, and outbound cargo went down 1.8 percent.






Pedestrians into Mexico All Cited Cities Dec. 2005 vs. Dec. 2006: Down **1.0%** (In Millions)





Rail Cars into Mexico All Cited Cities Dec. 2005 vs. Dec. 2006: Up **1.3%** (In Thousands)





Tourist Visas Issued for Entry into Mexico




Customs Revenues for the District of Laredo Dec. 2005 vs. Dec. 2006: Up **5.0%** (In Millions of U.S.\$)



Bridge Revenues All Cited Cities Dec. 2005 vs. Dec. 2006: Up **15.0%** (In Millions of U.S.\$)




Tourist Visas Issued All Cited Cities Dec. 2005 vs. Dec. 2006: Up **2.8%** (In Thousands)



Building Permits All Cited Cities Dec. 2005 vs. Dec. 2006 (Number of Permits): Up 16.8%






Power Connections All Cited Cities Dec. 2005 vs. Dec. 2006 (Residential – In Thousands): Up **2.6%**





Air Passenger Activity All Cited Cities Dec. 2005 vs. Dec. 2006






Port of Brownsville Total Cargo Dec. 2005 vs. Dec. 2006: Down **12.0%** (In Thousands of Metric Tons)
